AGREEMENT FOR TRANSPORTATION SERVICES

OBION COUNTY BOARD OF EDUCATION, hereinafter "Board," by and through its Director of Schools, David W. Huss, hereinafter "Director," enters into this AGREEMENT FOR TRANSPORTATION SERVICES with the **TRENTON SPECIAL SCHOOL DISTRICT**, hereinafter "District," by and through its Director of Schools, Sandra Harper, collectively referred to as "Parties," subject to the following conditions:

IN CONSIDERATION OF THE PROMISES HEREINAFTER STATED, THE PARTIES MUTUALLY AGREE:

1. **Duration of the Agreement:** Without regard to the date the Parties have entered into this AGREEMENT FOR TRANSPORTATION SERVICES, it is understood and agreed that the term of this agreement shall begin July 1, 2008, and terminate June 30, 2009.

2. **Terms of Agreement:** The Board agrees to:

- a) provide daily transportation services to the District for two (2) students who attend the West Tennessee School for the Deaf;
- b) transport said students from the agreed upon location in Trenton, Tennessee to the West Tennessee School for the Deaf, Jackson, Tennessee, and return, in accordance with the agreed upon protocol;
- c) provide a fully licensed bus driver; and
- d) provide a state approved school bus or other state approved mode of transportation.

The District agrees to:

- a) pay the Board at a rate of \$15.00 per day for each day service is provided, without regard to the students' attendance. It is further agreed that the terms of this agreement shall not exceed one hundred eighty (180) service days. The Board will invoice the District two thousand seven hundred (\$2,700) dollars in December 2008 and two thousand seven hundred (\$2,700) dollars in May 2009; and
- b) explain to all concerned parties that the Board is providing transportation services only, and any and all inquires should be directed to the respective District employee.

The Parties mutually agree that this agreement represents the entire understanding and no written or oral agreements, assumptions, or other statements will, in any manner, affect the provisions of this agreement unless agreed upon by the Parties and appended to this agreement as a supplement.

3. **Severability:** The Parties mutually agree that clauses, sentences, and parts of this contract are severable to the extent found to be unlawful or ineffective by a court of competent jurisdiction, and, if so held, the remaining provisions of the contract shall remain in full force and effect.
