Contractor shall provide equipment, installation, training and 1-year warranty for a new door access control system to be installed in the Ridgemont Elementary School.

Contractor shall provide an addition to the existing corporate access control network software from 40 to 64 Readers.

Other brands of equipment will be considered but must be equal to the part numbers listed below. Part numbers are of manufacturers Galaxy Control Systems, and Securitron Magnalock Corporation.

Work shall include but is not necessarily limited to the following major items:

**GCS 508i: Access Control Panel...**Expandable modular design, IP addressable for interfacing with the existing network, supports all reader technologies. With 8-door capability.

**Cost per unit: \$2,735.00**

**GCS PROXPRO: HID proximity card reader 5.5"-8"** read range or equal.

**Cost each: \$175.04**

**SEC M62GB: Magnalock** with 1200 Lbs. holding force with "bondstat". The "bondstat" feature will be used to notify the system the status of the door/lock, or equal.
