# **Regular Board Meeting**

## January 9, 2017

The Obion County Board of Education met in regular session on January 9, 2017, at the Board of Education Office. Board Chairman, Fritz Fussell called the meeting to order at 7:00 p.m. Mr. Brian Rainey led everyone in prayer. Mr. Russell Davis called the roll. Mr. Fritz Fussell, Mr. Brian Rainey, Ms. Keisha Hooper, Mr. Tim Britt, Mr. Scott Northam, Mr. Jared Poore, and Ms. Mickey Preciado were present. Seven members were present. There was a quorum.

### APPROVAL OF AGENDA

A motion was made by Mr. Rainey to approve the agenda. Ms. Hooper seconded the motion. **MOTION CARRIED.** 

### APPROVAL OF MINUTES FROM PRIOR MEETING

Consider/Approve Amendment to Board Policy #4.502 – Parental and Family Involvement – Upon the recommendation of Mr. Davis, a motion was made by Ms. Hooper to approve an amendment to Board Policy #4.502 – School Admissions on the first and final reading. Mr. Poore seconded the motion. **MOTION CARRIED.** 

*Middle School Football Presentation – Mr. Paul Decker –* Obion County Central High School Coach, Paul Decker presented the following points of interest regarding Middle Schools Football:

- Current consolidation of 7<sup>th</sup> and 8<sup>th</sup> grade into one team doesn't seem to be working;
- Suggested restructuring and having a football team at each school where ever the number of participants allow for a full team;
- Felt that putting teams back in their respective schools would result in greater participation and give players a feeling of ownership;
- Increased participation at the middle school level would hopefully impact the number of kids coming to OCCHS to play football.

Since the above noted item was for discussion only, action by the Board was not required.
