Mr. Britt seconded the motion. **MOTION CARRIED.**

DIRECTOR'S UPDATE

Dr. Watkins shared the following points of interest with the Board:

- The Obion County Schools Spelling Bee was held recently with participation by over sixty (60) students. Additionally, a large crowd was present to support the students during their participation in the event.
- Due to the collaborative efforts of Coach Moffitt and Principal Rogers, a STEM Initiative grant for \$5000 (five thousand dollars) was awarded to Black Oak Elementary School.
